The message is, "We won!" That's right, Southern Chapter has won the first-ever Chapter Project of the Year Award, to be presented at the Annual Meeting of MLA in Kansas City. We submitted the Eileen Cunningham Fund Endowment as our entry. This year, its Task Force reached their goal of raising \$100,000 to continue its good work, funding U.S. Learning opportunities for medical librarians from developing countries, including attendance at the annual MLA meeting. As a Southern Chapter member, you supported this effort: buying Raised Right in the South cups, blue and white map scarves, t-shirts at the Orlando and Puerto Rico meetings, and honoring your mentors with your donations. Other good news, quite fit to print: our chapter is in compliance with MLA regarding the ratio of MLA members within our chapter boundaries. We needed 50% and we have 60% of our members within the Chapter who are also members of MLA. (We actually have 81%, but 25 do not reside within our Chapter. What can I say!) We have great meetings in interesting places, which leads me to Memphis.

I hope that some of you will start dreaming of Elvis and get inspired to give a paper and send your abstract to Dixie Williamson, as described on your insert. The meeting's theme is, Catch the Rhythm: Jammin' with the Information Flow. I am living testimony that once you have seen The King, you life is never quite the same. I saw Elvis perform in Miami when I was ten years old and a reasonable facsimile in Puerto Rico at the business meeting, and I can hardly wait to go to Graceland... and of course, our meeting in Memphis.

# Southern Chapter wins MLA Chapter Project of the Year Award!

As indicated on our newsletter's front page, the Southern Chapter has won the first Chapter Project of the Year Award for our part in raising \$100,000, the goal set by the MLA Board of Directors Ad Hoc Committee to Establish the Cunningham Endowment in 1987. The goal was pursued in our region by the Chapter's Task Force to Promote the Cunningham Fellowship. Chapter members active in this endeavor have included Mark Hodges, currently our Cunningham Fellowship Liaison; Vislava Tylman, Task Force Chair 1992-1995, along with members Diana Atkins, Peggy Hsu, Faith Meakin, Leticia Perez, Barbara Ruelle, Neeta Shah, Ann Carroll Bunting, Tom Williams, and Martha Watkins. Many a cup, scarf, magnet, t-shirt, mentor sticker and letter have helped make this goal a reality.

One of Martha Watkins' last endeavors before her death was to help Mark Hodges and Jan LaBeause write the application for this award. She and many others worked on this project through the last decade, and we thank each and every one of you.

The Cunningham International Fellowship was originally endowed by a bequest to MLA from Eileen Roach Cunningham at the time of her death in 1965. Cunningham was the long-time director of the Medical Center Library at Vanderbilt and the compiler of the classification that bears her name. The goal of the endowment was to bring librarians from overseas to study and learn modern medical library practice at institutions in Canada and the USA. Unfortunately, the endowment was not sufficient to maintain the fellowship, and the MLA Board of the day decided to use both the interest and the principal until the latter was exhausted. In 1986, the principal was almost completely spent and the program would likely have been terminated. Accordingly, a group of concerned MLA members (Henry Lemkau of this region among them) persuaded MLA to attempt to raise an endowment to continue the fellowship. Because of Eileen Cunningham's links to the South, the Southern Chapter embraced this endeavor. Our efforts paid off, and our methods and success in raising a large part of the money have won for us this award.

The Chapter Project of the Year Award was established by the MLA Board of Directors in 1995. The project must relate to excellence in projects demonstrating advocacy, leadership, service, technology or innovations related to the advancement of health sciences librarians but also beyond the normal operational programming of the Chapter. The project had to be completed during the twelve months immediately preceding the application deadline. There will be a cash award of \$500 presented to our Chapter at the MLA Annual Meeting. The award money is to be used to enhance the programming of the recipient chapter's annual meeting. Ever after, it will be called the Majors Chapter Project of the Year Award, as it has been "well endowed" by Majors Scientific Books.

# Tell a Doctor, TeleHealth: A Telesymposium of Tools and Techniques

Georgia was the place to be on Saturday, March 16, for the first statewide telesymposium on biomedical information technology hosted by Emory University, Medical College of Georgia and Mercer University School of Medicine. The symposium was broadcast via the GSAMS statewide distance learning system and was received at 5 sites: Atlanta, Augusta, LaGrange, Macon and Rome. Funded in part by a technology awareness day grant from the NN/LM Southeast/Atlantic Region, the day was the result of a 3-library planning committee that met only three times in person, but met held many "virtual" meetings by email and conference call.

Highlights of the program included a keynote address by Dr. Daniel Masys, Director of Biomedical Informatics at the University of California, San Diego School of Medicine. Formerly, Dr. Masys served as Director of the Lister Hill National Center for Biomedical Communications at the National Library of Medicine.

A major portion of the program highlighted technologies at each of the four medical schools in the state. These showcases covered such topics as dental and nursing educational simulations, technology and problembased learning, treating phobias with virtual reality, Adonis, GaIN, radiology CAI, and telemedicine.

The program also included three panel discussions with speakers at several locations, demonstrating the capabilities of teleconferencing. Topics included the Internet, Galileo and MedWeb; telemedicine; and a final panel commenting on the technology showcase.

At each site, participants could also visit exhibits of local interest and the NN/LM exhibit (including Grateful Med).

In spite of a cruel blow delivered by Mother Nature the night before (knocking out the main GSAMS connection in Atlanta) which delayed the beginning of the program, the day was a success for all involved. submitted by Carol A. Burns



### Research Committee

The SC/MLA Journal Usage Study Phase III is complete. Partial results will be presented at the Library Research and Public Services Sections joint session at MLA, *Using Scientific Evidence to Improve Public Services in the New Information Frontier*. This presentation focuses on the hospital libraries in Phase III, in particular the benefits of their participation relative to decision-making in hospital public services: which titles are essential to responding effectively to user needs and when is interlibrary loan the most cost-effective solution to access?

The Phase III study yielded average frequency of use; cost per use; extent of commonality among frequently used titles including their occurrence on the Brandon-Hill list; subject analysis; incidence and commonality among non-used titles. The study illustrates the value of using scientific evidence in library management and decision-making. Additional data collection may yield actual benchmarks.

The Phase III study included 50 libraries, and the Research Committee gratefully acknowledges the hard work each library put into its data collection and reporting. Many thanks to the following libraries:

#### In Memorium

Sadie Hill Rainsford, former Librarian at the Greenblatt Library, Medical College of Georgia, died at her home on February 4 as the result of a tragic fire. Ms. Rainsford was 79, and a lifelong resident of Edgefield County, South Carolina. She held an A.B. degree in English from Columbia College and a library degree from Emory University. In 1942, she accepted a position as Assistant Librarian at the MCG Library, beginning a career of service to the Medical College that spanned 33 years and three separate library locations. In 1950, Ms. Rainsford was named Librarian, and assumed this position as the only professional in the MCG Library. As such, she was solely responsible for the planning, management and administration of a major medical library.

During her tenure, Ms. Rainsford expanded the book collection to almost 100,000 volumes, a sevenfold increase. The books were recatalogued, using the more specialized National Library of Medicine and Library of Congress classification schemes, and a more organized circulation system was implemented. Ms. Rainsford modernized the library by introducing such innovations as photoduplication and teletype equipment.

Ms. Rainsford was an active participant with both MLA and the Southern Regional Group (the original name for SC/MLA) during her career at MCG. She served as both Vice Chairman and as a member of the various committees of the University System of Georgia, particularly on the committee relating to academic status for librarians.

In June, 1975, when Ms. Rainsford retired, The Board of Regents of the University System of Georgia conferred upon her the title of *Librarian Emeritus*, a title that remains unique to her. submitted by Donna J. Trainor




