Medical University of South Carolina Library, Charleston, SC

The library's computer classrooms are sporting upgraded capabilities this spring. Sound systems, including lavalier microphones and in-ceiling speakers will make classroom sessions easier to hear and give instructors freedom to move around the room. New projectors are so powerful you can keep the lights on during class. Both are great improvements, but rather ho-hum.

The other new technologies are much more exciting. The instructor's computer in each class-room is now equipped with a Sympodium Interactive Pen Display. This gives you the capability of drawing on and annotating the computer screen! Is there a particular term you want to draw attention to? Circle it in red. Perhaps you want to highlight a phrase or part of an equation - use the highlighter tool. You can even save a copy of your annotated screen to a file. These are only a few of the Sympodium's capabilities.

We also have two document cameras that will project 3 dimensional objects on the large screens. The clarity and sharpness of the image is impressive, whether you are showing the detail on a flat image on paper or examining the wrinkles in a model of the brain.

Hands on Health-SC and Go Local-SC: Online Access to Health Resources & Services Now in Spanish

The outreach projects of the MUSC Library, Hands on Health-SC and Go Local-SC, are now available in Spanish. Hands on Health-SC (http://www.hohsc.org) is a consumer health Website designed for the people of South Carolina. Its purpose is to promote healthier citizens and healthier communities in South Carolina by providing a free, easy-to-use, content-rich source of good quality health information. The site is primarily a collection of links to health and wellness sites that have been evaluated by MUSC library staff. South Carolina 's biggest health issues (diabetes, stroke, HIV/AIDS, cancer, family violence, suicide, and others) receive special treatment. Each issue is the focus of a complete article written in plain language, in a question and answer format that covers basic information about the disease or problem.

The Spanish Go Local-SC (http://www.hohsc.org/golocal/) is the first Spanish-language GoLocal system in the country. GoLocal-SC gives South Carolinians a way to find health services in their own or nearby communities from the Hands on Health-SC Website. Go Local-SC is also linked to the National Library of Medicine's national consumer health Website, MedlinePlus.

Benchmarking Network by Jan Haley and Linda Garr Markwell

For the past several years, I have had the opportunity and wonderful experience of serving the Southern Chapter as the Benchmarking Liaison to the MLA Benchmarking Network and as the Benchmarking cheerleader within Southern Chapter. It has been so exciting to work with so many of you, as well as the MLA Benchmarking Committee. Because it such a great position, I decided that I should allow someone else to have some of the fun. The SC Board has approved my successor, Jan Haley. Welcome, Jan!!

Jan is not new to benchmarking. She has worked on the SC Benchmarking Committee, serving as the Tennessee representative. She worked tirelessly in encouraging the Tennessee librarians' participation in the MLA Benchmarking Network data entry. As a result of all her enthusiasm and work, Tennessee had more participants than any other state within the Southern Chapter.

It is with full confidence that I give the reins of benchmarking to Jan. Congratulations, Jan!!

I want to personally thank Linda for her efforts over the years and her confidence in me to fill this role. Her mentorship has been a truly delightful learning experience and her efforts during my time on the SC Benchmarking Committee have instilled in me a passion for this ever-growing in importance topic.

Remember those compare and contrast essay questions and English papers we all had to deal with during our academic pursuits? I hate to admit it but I actually liked those types of assignments. To me, benchmarking is simply the numeric complement to those scholarly drills. Per our MLA Benchmarking guru, Kate Corcoran, the data from the 2007 MLA Benchmarking Network's Interactive Report Site survey is in the final testing stages. Even if you did not have the opportunity of entering your information, you may benchmark your hospital library against those that did enter data.

If you are just learning about benchmarking and the MLA Benchmarking Network, there are some resources which may help you to get started for the next entry period. Those resources are:

- 1. MLA's Hospital Libraries Section (HLS) has a fantastic wiki at http://mla-hls.wikispaces.com/Benchmarking with information about the Benchmarking Network. You will find worksheets for Data Collection posted there. The worksheets can be used as guidelines on the statistics and data you should be collecting now to be ready for the next data entry period.
- 2. You will also find information on the wiki about a book Rosalind Dudden has written on benchmarking, Using Benchmarking, Needs Assessment, Quality Improvement, Outcome Measurement and Library Standards: A How-To-Do-It Manual. The book was published in July, 2007 from Neal-Schuman.
- 3. Both the 2002 and 2004 MLA Benchmarking Network data are online at http://www.mlanet.org/members/benchmark/index.html and are available for access by the participants of those surveys free of charge. Non-participants may access the data for a fee.

Financial Update

As of March 1, 2009, our checking account balance was \$16,376.43. This figure is based on the February 2009 bank statement. In March, we received a check from the SCMLA 2008 annual meeting for \$3715.91. That check represented the return of \$2000.00 in seed money provided to the Conference Committee for upfront costs and \$1715.91 in SCMLA 2008 annual meeting income. This deposit will appear on our March 2009 bank statement and is therefore not included in the above balance. Congratulations to the SCMLA 2008 Conference Committee for being able to turn a profit on the 2008 meeting!

Our two CD accounts matured on February 28, 2009. The SCMLA Scholarship Fund CD was reinvested in a 12-month CD that will pay 2.75% APY. The current balance in that account is \$24,925.27, which includes \$1775.00 that was donated to the scholarship fund in 2008. This CD will mature on 03/05/2010. Our long term goal is to endow the Scholarship Fund CD to cover the costs of all SCMLA awards.

The SCMLA General Fund CD was reinvested in a 9-month risk free CD that will pay 2.5% APY, maturing on 12/05/2009. Since it is risk free, we can withdraw and/or reinvest it at any time without paying a penalty. This will provide us with some flexibility without sacrificing much in interest, since there is only a 0.25% APY difference between it and the 12-month CD. If the economy should improve and interest rates go up between now and December 2009, we can reinvest it at a higher rate. The current balance in that account is \$26,612.31. This CD was set up to provide a 'rainy day' account to shelter the association during tough economic times.



- Focus on CAREER How do you stay motivated and stay 'unstuck"? How do you lead when you aren't a supervisor? Have you got vita/resume/interview advice? Do you have a mentoring experience to share?
- Focus on TECHNOLOGY Are you using an old technology in a new way or a new technology in an old way? Have you discovered any new tips or tricks? How are you using social software to connect with people?

Abstracts will be evaluated on originality, innovation, organization and clarity of presentation, and relevance to improving service or practice.

Paper & Poster Submission Instructions

Proposals must be submitted in the form of a structured abstract not more than approximately 300 words in length. You may use the e-form http://library.utmem.edu/scmla09/submissions/ to submit your proposal or, if the form doesn't fit your needs, you may e-mail your abstract proposal as a Word attachment to Sandy Oelschlegel <soelschl@utmck.edu> (for paper abstracts) or to Suresh Ponnappa <ponnappa@mail.etsu.edu> (for poster abstracts).

In order to follow a blind review process, all submissions will be stripped of any information identifying the authors or institutions and given to a panel of reviewers. The primary author will be notified of the reviewers' decision by July 15. Additional information (i.e. time, location, setup instructions, etc.) will be sent with acceptance notification.

Those presenting in Memphis must be registered for the meeting.

Contributed papers are oral presentations; a complete text of the paper is not required.


