
reg Baugh Biomedical Library, University of South Alabama, Mobile, AL

Shimberg Library received a NN/LM SE/A Digitization Award. The staff of the Shimberg Health Sciences Library will purchase equipment to enable the digitization of the donated historical materials about the medical history of the Tampa Bay area and founding of the University of South Florida Colleges of Medicine, Nursing, Public Health and School of Physical Therapy. Once digitized, the materials will be available from the library's website.

University of Florida Health Science Center Libraries, Gainesville and Jacksonville, FL

The University of Florida has been awarded a \$12.2 million grant from the National Institutes of Health to lead the project entitled "VIVO: National Network for Biomedical Researchers." VIVO is a discovery platform created to facilitate the identification of discipline-specific researchers. This open source Semantic Web network of institution-specific databases will allow any interested party to identify potential collaborators and retrieve contact, publication, funding, resource, professional association, and other locally determined information. Installations have been implemented at partner institutions Cornell University (initial developer of VIVO in 2003), Indiana University, Ponce School of Medicine, Scripps Research Institute, Washington University in St. Louis Medical School and Weill Cornell Medical College; a national platform will be created and evaluated by the end of the grant period (2011). VIVO was brought to the University of Florida from Cornell by two librarians at the Marston Science Library: Val Davis and Sara Russell Gon-

zalez. UF Health Science Center Libraries' faculty partially funded by the grant include Cecilia Botero, Ellie Bushhousen, Nita Ferree, George Hack, Rae Jesano, Nancy Schaefer, and Michele Tennant. The library-based support model for VIVO employed by the University of Florida provides many roles for library faculty and staff, including metadata and ontology creation, data curation and management, IT development and support, publicity, instruction, usability testing, and help desk services.

Nancy Schaefer was granted tenure and promoted to Associate University Librarian. A graduate of the University of Washington's graduate library science program, she is currently serving on the MLA Books Panel and Public Health/Health Administration section's Client Relations Committee, Southern Chapter/MLA Research Committee and as President of the Florida Health Sciences Library Association.

Marina Salcedo, Ellie Bushhousen, and Kathryn Summey recently received a \$4,500 mini-grant entitled "The Smart Phone in Medicine: Creating a Mobile Accessible Website for Clinical Practice." The goal of the project is to build a mobile accessible website organized into categories of reviewed applications that can be used in various clinical settings and on multiple platforms. Kathryn Summey is the Principle Investigator. The grant runs through October 2010.

In October, the HSC Libraries co-sponsored the fifth Florida Genetics Symposium, an annual meeting of some of the top scientists in genetics, bioinformatics, and biotechnology. It featured a keynote address by Leroy Hood from the Institute for Systems Biology in Seattle, Washington. Michele R. Tennant is a founding member of the Florida Genetics Symposium organizing committee.

Michele Tennant attended the Biomedical and Library Informatics Review Committee meeting at NLM November 5-6. Prior to that she presented four posters at the International Congress on Medical Librarianship held in Brisbane, Australia, August 31-September 4, 2009:

- Learning from Users to Create Intuitive Resources: Not Seeing the Forest for the Trees
- Library-based Support for Clinical and Translational Science Initiatives: The University of Florida Experience
- Reporting Structure of Academic Health Science Libraries
- Using "E-Learning" Technology and Presentation Software to Enhance Genetics

University of Tennessee Health Sciences Center Library, Memphis, TN

Recently the University of Tennessee Health Science Center (UTHSC) Library received an Express Planning and Assessment Award from the National Network/Libraries of Medicine, Southeastern/Atlantic Region to begin a SMARTT project. SMARTT (Smart Methods for Accessing Reliable Information Using Telephone Technology) funds will be used to determine the feasibility of offering workshops that explore uses and features of smartphones and their ability to access reliable sources of healthcare information. Brenda F. Green, MLS, Coordinator for Instructional Services, is the project manager. Zachary E. Fox, BS, Computer Information Specialist in the department and currently a MSIS student, is the technology consultant and assists with training. Following a multidisciplinary literature review, research and analysis of current applications, and input from key planning participants, a focus group will be convened to assist in the design, delivery and evaluation of a smartphone workshop. A pilot workshop will be offered, evaluated, and analyzed

for strengths, weaknesses and opportunities for future implementation. Based on those findings, a modified workshop will be offered to a target group. Following review and analysis of the modified workshop, recommendations will be made concerning the feasibility of hosting smartphone workshops for campus and community partners. The SC/MLA Scholarship Fund began as a memorial to honor Martha Watkins. Martha was a founding member of the Southeastern Conference of Hospital Librarians (SCHL) and a life-long leader, friend and mentor of SC/MLA. The scholarship fund was begun with the SCHL treasury after the organization disbanded in 1995, and has grown each year through donations. Originally, the fund was established to help a hospital librarian take a course or workshop at the Southern Chapter annual meeting by applying for the Martha C. Watkins Memorial Scholarship (http://www.scmla.org/mom.htm). However, that award is now endowed, so the scope of the scholarship fund has been expanded. We are hopeful that it will eventually provide funding for all SC/MLA Awards and Grants.

Donations can be made throughout the year, at the meeting or with your annual membership renewal. Donations may be designated to the general scholarship fund, or can be specified for one of the awards or grants: Research Grant, Academic Librarian of the Year Award, T. Highlights from the National Magnet Nursing Conference Diane Rourke

National Magnet Nursing Conference Oct 1-3, 2009 Louisville, KY


First I would like to thank MLA and the Hospital Libraries Section for partially funding my attendance at this conference. I was not alone: recession or not, over 5000 nurses attended the conference this year as last year and the one before. There are now 352 Magnet hospitals; most are in the U.S. but there were representatives from all over the world attending. Hospitals in New Zealand and the Lebanon were "magnetized" this year. Though the Magnet model has been modified and the criteria tightened, institutions still covet their place in this inner circle of excellence in nursing care. This year 90 hospitals were recognized for Magnet designation or re-designation. The re-designations happen every four years, by application and site visit evaluation. Now the Magnet criteria are recognized by US News and World Report as a criteria for its "best hospitals" list, so it is quickly becoming a standard of health care excellence. Over the last eight years, the list of Magnet hospitals has grown from 18 to 352, an average growth rate of 32% annually. One of my Magnet hospitals was the eleventh in the country. We have a combined 5 Magnet nursing designations, with three other Baptist Health South Florida hospitals now also on the journey.

As in years past, the conference kicks off at 9:00 am with a local band; the site being Kentucky, this year it was a blue grass band. The awarded institutions sit in front rows. As their organization's slide appears on the screen and their hospital's name is called, the groups usually jump up, throw confetti, beach balls, candy, pom poms, and generally have a great time dancing and celebrating their successful Magnet journeys. The nurses wear t-shirts and funny outfits celebrating their organization or city...all this at 9:30 in the morning.

The conference may start out with fun and games, but it soon gets serious. General sessions include updates from ANCC Magnet leaders on implementation strategies and changes in the program; additionally, there are plenty of concurrent and poster sessions on the Magnet forces in action in

Magnet hospitals. This year Deniz Ender, librarian from Rex Healthcare in Raleigh, NC, presented a poster titled "Promoting Critical Thinking through Journal Clubs") Last year I presented a paper titled: "Next stop on your Magnet Journey: the hospital library". So the message is we librarians can get papers accepted for presentation at the annual Magnet nursing conference. Here is the new Magnet Nursing Model:

All forces are expected to be reflected at the bedside as well as the board room. Following the directions of the revised application manual, what is said in the application must reflect what really is going on in these Magnet hospitals. The bedside nurse is expected to be a transformational nurse as much as the chief nursing officer. The nurse's professionalism needs to be shown, in implementing changes, based on evidence based practice and research initiatives in their hospitals. More BSN prepared nurses are the expectation, especially at the nursing leadership level, including nurse managers. Chief nursing officers at Magnet hospitals now all have graduate degrees, BSN and Master's degrees, for many, the Master's degree is an MBA or MS in Health Care Administration. By 2011, 75% of nurse managers and directors in Magnet hospitals must have BSN degrees; by 2013 it will be 100%. So as the criterion tightens, there are many opportunities for hospital librarians to extend their role in these settings and assist their organizations on their journeys.

I know that many of our members work in libraries that are living laboratories for innovation and transformation. By connecting to this conference, we get a closer view of the ideas and expectations on how to integrate these forces into our professional library "magnetism". There were so many papers this year on journal clubs and evidence based practice. Many hospitals have electronic nursing journal collections and resources: now is the time to push them out to our nursing staff on their Magnet journeys.

On October 14, I presented a webinar to the Southeastern Atlantic Region's hospital librarians on highlights of this conference and the new Magnet model. The presentation is available at their website. (http://nnlm.gov/sea/services/webconf/hosplibrarian/index.html) I recommend continuing the relationship with the ANCC Magnet Recognition program. Next year's conference is in Phoenix, AZ. October 2010.
