

ALABAMA

University of South Alabama, Mobile, AL

After more than 40 years of service at the University of South Alabama, Geneva Bush Staggs is retiring from her current position as Director of the Charles M. Baugh Biomedical Library. Staggs began her career as the cataloging librarian at Mobile College. In 1979, she joined the library staff at the Medical Center site of the Biomedical library. After five years she accepted the challenge of setting up library services for the University's newly developing Baldwin County campus in Fairhope and Bay Minette. Since returning to the Biomedical Library, Staggs has held several increasingly responsible positions including Head of Public Services and Assistant Director for Hospital Library Service and has been involved in developing and implementing library services in reference, education and consumer health.

Awards received include the Southern Chapter Medical Library Association's Hospital Librarian of the Year in 2012, and the Medical Library Association's prestigious Lois Ann Colaianni Award for Excellence and Achievement in Hospital Librarianship in 2015. Staggs has been a member of the Academy of Health Information Professionals for 20 years, the last ten as a distinguished member. The Academy recognizes accomplishments in professional development and service.

Staggs has multiple publications, as well as, many presentations at professional meetings and conferences. Her writing career began with coauthoring "Finding the Source of Medical Information: A Thesaurus-Index to the Reference Collection" in 1985 and her first presentation was at the Alabama Academy of Family Physicians in 1982. Her resume includes an additional 69 publications and presentations directed at either health information professionals or consumers.

Staggs has served locally, state-wide, regionally and nationally. Locally on many University, USA Health System, and community committees including the Southwest Alabama Health Literacy Council. State-wide appointments include the LSTA Advisory Council of the Alabama Public Library Service, multiple committees and leadership positions of the Alabama Health Libraries Association, and as Secretary of the Judson College Alumnae Association. Staggs served regionally as the Secretary of the Consortium of Southern Biomedical Libraries, several committees of the Southern Chapter of the Medical Library Association, and on ten visiting committees for the Southern Association of Colleges and Schools Commission on Colleges. Her latest national involvement was

with the Association of Academic Health Science Libraries and Medical Library Association Joint Task Force on Legislative Development.

Staggs graduated from Judson College in 1975 with a degree in education and school librarianship and from the University of Kentucky with an MS in library science in 1977.

The Clifford E. Graese Community Health Library has exciting news to share! To expand health literacy education and resources to the communities of Orlando and surrounding areas, Jessica Daly, Consumer Health Librarian, received the 2020 Orlando Health Community Grant in the amount of \$18,500. These dollars will fund the "Orlando Pediatric Health Literacy" program. Pediatric caregivers will be empowered by gaining research and resources needed for improved health and overall quality of life for the children they love.

The program will partner with Orlando Health - Winnie Palmer Hospital for Women and Babies, as well as Orlando Health - Arnold Palmer Children's Hospital. On top of working with both accredited and highly acclaimed hospitals, the program will also benefit all Orlando Health Physician Associates pediatric practices, offering not only resources and research but in person and online health literacy education. Collaborations with East Orange Community Center of Orange County, the Ronald McDonald House of Arnold Palmer Children's Hospital, iKids Pediatrics and the Orange County Public Library will offer pediatric caregivers free consultations with the Consumer Health Librarian and assistance through email, phone calls and even virtual consultations using Skype or Facetime capabilities.

The Consumer Health Librarian will also purchase paperback children's books for pediatric patients and their siblings in order to promote not only literacy but health literacy as well. These books will be placed in all partnering locations. Health Literacy information kiosks will be purchased and stationed in pediatric patient waiting areas within hospitals and practices in order to offer contact information for the Consumer Health Librarian and to promote upcoming Health Literacy educational sessions. Making the services of the Consumer Health Librarian visible in these areas will increase awareness and usage of health literacy assistance. This grant enables Jessica the funding for things such as marketing, print resources, food for events, travel and even professional development in the area of pediatric medicine, which would otherwise not be possible.

Librarians Mentoring FIRE Students

Those projects inlcuded: "How Electronic Health Records Help and Hurt Patient Outcomes: A Review," "Effects of Clinical Mobile Applications on Enhancing Medical Student Cognition," and "Physicians' Opinions on the Effectiveness of Electronic Medical Records on Patient Care."

Shalu Gillum, Head of Public Services, is mentoring a first year student who is working on a literature review, titled, "Association of Time Between Onset and Diagnosis of Necrotizing Fasciitis in the Upper Extremity and Mortality Outcomes: A Literature Review." 

The library is hosted the NLM Traveling exhibit "Fire and Freedom: Food and Enslavement in Early America", which highlights the knowledge of farming and food acquisition of indentured servants, Native Americans and African slave labor in the early colonial era.

Special Projects and Events

To get general feedback on our services, space, and collections from library users, our fall "3 wishes" campaign asked users for their top wishes for the Health Science Center Library. While the 199 wishes described by the 80 respondents included a wide variety of suggestions, the requests most frequently related to improvements to the library space in general: furniture, food available within the library, air conditioning, and printing options. The library's management team responded with some immediate changes, such as: more whiteboards, better library closing process, purchasing human skeleton models, and added some ideas to longer-term space planning efforts and future areas of advocacy.

Wishes for the Library





The Passport to Wellness contains 12 wellness activities for students, staff and faculty to participate in at the Health Science Center Library in Gainesville. The passports are available at the circulation desk and are stamped there when owners have completed an activity such as attending art-making sessions, visiting with a therapy dog or using the library's under-desk exercisers or energy pods. Different prizes are awarded those completing 7 and 10 of the activities. The program will run through the Spring 2020 semester.



On December 11, 2019, the HSC Library sponsored a panel discussion of UF nursing faculty critiquing popular representations of nurses in television and movies. The event was part of the HSC Library's exhibition of a travelling exhibit from the National Library of Medicine, Pictures of Nursing: The Zwerdling Postcard Collection.

On February 18, 2020, Margaret Ansell represented the Health Science Center Libraries and other UF Libraries at the annual Gator Day at the Capitol event in the state capitol building in Tallahassee. With representatives from the various colleges at UF, she displayed some of the exciting work happening on campus, including the libraries' digitization efforts, research support, and 3D printing services. She spoke with Florida legislators and visitors to the Florida Capitol about the importance of the libraries as the "information backbone" of the state

through the libraries' support of UF students, staff, and faculty. Visitors walked away with 3-D printed orange and blue gator tie pins made by miniature printers that the libraries have

available for checkout.

Black History Month Presentation and Photo Exhibit



Calder Library hosted the presentation and accompanying photo exhibit, <u>Bay Yo Lapawol - Haitian Women's Barriers to Cervical Cancer Prevention and Control</u>, on Monday, February 4, 2020 by Dr. Rhoda Moise. The presentation and photo exhibit centered on her use of *photovoice*—a Community Based Participatory Research (CBPR) method that uses digital media to guide conversations—in her work on cervical cancer in Haiti. Dr. Moise uses photovoice to engage women in semi-structured individual and group interviews grounded in cultural empowerment that allow them to *bay yo lapawol*, or *let their voices be heard* through personal narratives. The exhibit was hosted by Calder Library from February 4-29, 2020.

Rhoda K. Moise received her Ph.D. in Prevention Science and Community Health at University of Miami Miller School of Medicine in May 2019. Dr. Moise works at the intersection of science, health, and policy to promote wellness for all by engineering health systems with equity as the foundation. Through research, her goal is to create products and services which solve systemic issues for health advancement of the globally underserved with focus on women's health.

The first half of the day featured a 4-hour interactive session facilitated by Shannon Jones, Director of Libraries, Medical University of South Carolina; Dr. Kimberly Reynolds, Assistant Professor of Clinical Pediatrics at the University of Miami Miller School of Medicine; and Kelsa Bartley, Education and Outreach Librarian at the Calder Library. A panel was held in the afternoon to discuss the impact of implicit bias in various campus work-place settings. Panelists included Ms. Jones, Dr. Reynolds and Dr. Nanette Vega, Executive Director of Programs for the Office of Diversity, Inclusion, and Community Engagement at the University of Miami, Miller School of Medicine. The panel discussion was moderated by Kelsa Bartley. The session was well attended, with over 50 participants from the Calder Medical Library, the UM Libraries on the Coral Gables Campus, the Rosenstiel Marine and Atmospheric Science Library, and the UM Law library, as well as staff from UM's Lowe Art Museum.

Rowland Medical Library, University of Mississippi Medical Center, Jackson, MS




Eskind Biomedical Library Activities



The exhibit is sponsored by the Annette and Irwin Eskind Family Biomedical Library and Learning Center, the Jean and Alexander Heard Libraries at Vanderbilt University, the Curb Center for Art, Enterprise, & Public Policy at Vanderbilt, and a grant from the National Library of Medicine (NLM), National Institutes of Health (NIH) under cooperative agreement number UG4LM012340 with the University of Maryland, Health Sciences and Human Services Library.

History of Medicine Collections

Chris Ryland's review of Dr. Mary Ellen Pethel's book, Athens of the New South: College Life and the Making of Modern Nashville, has been published in the latest issue of The Journal of East Tennessee History. Dr. Pethel's book examines the evolution of institutions of education in middle Tennessee, including the stories of Vanderbilt University and Peabody College.

Vanderbilt's History of Medicine Collections recently acquired two rare books in the history of medicine, both first editions. First published in 1822, Thomas de Quincey's *Confessions of an English Opium-Eater* was one of the first addiction memoirs, becoming a literary sensation instantly upon its release. De Quincey chronicles his experiences in London's underworld, as well as the attractions and dangers of opium. Celebrated for its honest and even cultured approach to its lurid subject matter, the book was also criticized for glamorizing drug abuse.

Nathaniel Hulme's Safe and Easy Remedy Proposed for the Relief of the Stone and Gravel, the Scurvy, Gout, etc. was published in 1778. This remedy was "fixed air," otherwise known as carbon dioxide, which was thought to change the chemistry of the urine and thus cure gout and dissolve bladder stones. But instead of prescribing carbonated water, Hulme proposed that patients make the fixed air themselves by ingesting salt of tartar followed quickly by weak spirit of vitriol. Hulme was so taken with the concept that he also applied the cure to consumption, fevers, dysentery, scurvy, and even worms.



Meharry Medical College, Nashville, TN

National library services veteran and former Dean of Beaman Library at Lipscomb University, Nashville, Tennessee; Sandra Parham has been named Library Executive Director of library services at Meharry Medical College.

As director of library services, Parham will oversee the management and operation of the college's medical library. She will lead strategic planning in addition to enhancing and expanding the library's digital holdings, special collections and programming among other activities.

"Ms. Parham is dedicated to the advancement of the effective use of the library and associated technology components which enhance the student, instructional, and research mission of the college", said Dr. Dexter Samuels, Vice President of Student Services. "She is a seasoned and successful educator and administrator who brings to the Meharry Medical Library a wealth of ideas and experience that will greatly benefit our institution."

Parham, a Nashville native, is passionate about serving the Meharry community. Parham comes to Meharry after five years of service at Lipscomb's Beaman Library where she changed the landscape of the library by adding an art gallery to the building and additional digital resources to enhance the collection.

Previously having spent 15 years as dean of the library at California State University, Dominguez Hills, a university of nearly 15,000 students located near Los Angeles, she spearheaded the institution's \$50 million building project that doubled the size of the university library. In addition to leading the daily operations and strategy of that library, Parham also added a multicultural art gallery with African art and an events gallery – the "extra" learning opportunities that libraries can offer. While there, she also raised millions of dollars through campaigns and grant opportunities. In addition to her work in library services, Parham launched a nonprofit homeless ministry, Healing and Hope 4 the Homeless, which continues to serve the homeless community in South Central Los Angeles.

A 1976 graduate of Fisk University, Parham said that her love for libraries was enhanced when she was an English major at the institution where she spent many hours in the John Hope and Aurelia E. Franklin Library, studying, reading and realizing that a library is a vital part of the academic community. Parham has a Master of Library and Information Science degree from the University of Michigan, where she also received certification as a medical librarian.

After graduating from the University of Michigan, she began her in career in Detroit, Michigan, eventually returning home to Nashville to work at Tennessee State University Library. Continuing to serve at HBCU's, she relocated to Houston, Texas where she served at Texas Southern University (TSU) Library for some 20 years and had the privilege to become the archivist for the late Congresswoman Barbara C. Jordan. As Archivist and Coordinator of Special Collections at TSU, she published two works, A Catalog of Traditional African Art and Barbara Jordan: Selected Speeches.

Parham notes that she is indeed pleased that her career has come full circle. "It has always been my desire to return to Nashville and utilize the medical certification garnered at the University of Michigan. I could not have imagined a better opportunity than to be at Meharry Medical College Library serving the community in which I was born and raised."
