

#### **UAB Libraries to host virtual Library Carpentry Sessions**

The University of Alabama at Birmingham Libraries has been selected by the Network of the National Library of Medicine, Southeastern Atlantic Region to host a series of Library Carpentry workshops. Library Carpentry introduces core concepts in data science and software development to help prepare librarians, researchers, and academic faculty, to interact effectively with data as an evolving information resource. The workshops are being coordinated by a UAB-based taskforce that includes representation from the UAB Libraries faculty, Center for Clinical and Translational Science, UAB Research Computing, and the Alabama Health Libraries Association. The virtual workshop sessions will be held on the fourth Fridays of January, February, March, and April 2021 from 8:30 am -12:30 pm.

#### Pediatric Partnership in Health Literacy

As a consumer health librarian and parent, I understand the importance and direct effect a pediatric family caregiver's low health literacy can have on the health and quality of life of children. My goal was to create health education webinars for caregivers. How to make this a reality was the challenge. I quickly realized an expert in pediatric medicine was essential in making this project a success. Collaboration with a pediatrician gave my work medical and professional credibility to not only fellow medical professionals but also the parents I hoped to reach.

Months before I even thought of this idea, I had connected with a local pediatrician, Dr. Jannette Negron, who has a passion for improving the lives of children. We agreed to meet and discuss my ideas.

Dr. Negron was unfortunately seeing pediatric patients who were addicted to online pornography, vaping, and being placed in danger due to their cell phones, often without their parent's knowledge. Adolescent and teen patients shared with Dr. Negron, in confidence, asking for help because they knew their behaviors were detrimental to their emotional and physical health.

After discussing these three topics, we began to plan and create presentations to use as



the basis for the three webinars we would record and then share with fellow pediatricians, parents, and other pediatric family caregivers in the community. The title of the webinar series was "Not My Child" because when Dr. Negron confronted parents this was normally their initial reaction. The three webinars are "The Dangers of Pornography", "The Dangers of Cell Phones" and "The Dangers of Vaping". During each video, parents are given facts on how each of these topics affect the emotional, mental and physical health of their children while offering sound medical advice and sources of information from a certified and experience pediatrician.

As COVID-19 began the project was placed on hold but we soon realized this was too important to postpone. As a result of

using a virtual meeting platform, we were able to record the webinars together from two different physical locations, which was not our original plan. We realized the platform we were planning to use worked only if we had been able to be physically present together, so a decision to use Microsoft Teams was made giving us the ability to complete the project from our separate office spaces. I served as the host while Dr. Negron presented the content of the health education session.

Now that the webinars have been recorded, the health education video series will be promoted

and shared. I worked with a marketing representative from Orlando Health who was willing to promote the series on social media platforms such as Instagram, Facebook and Twitter. Due to Dr. Negron's reputation and connections within the medical community, I was able to email promotional materials to fellow pediatricians across the state of Florida, giving them the ability to post signs inside their practice exam rooms as well as print out flyers to offer to parents. Future promotion will include the Orange County Library System, community organizations, the Ronald McDonald Houses of Orlando, library listservs and professional organizations. One can only imagine the endless number of lives that will be touched and improved because one physician and a consumer health librarian took the time to meet and create three health literacy videos for parents and family caregivers on topics which were considered taboo.

#### University of Florida Health Science Center Libraries- Gainesville, FL



In early June, UF HSCL in Gainesville opened its second floor to students and residents with UF HSCL designations on their ID cards for swipe access. On July 6, UF began a "curbside pickup" of print materials at its main library and HSCL, by online request for specific materials and pick-up appointment only. On August 10, UF HSCL opened its first floor to the UF community as a whole, also with significant furniture removal, and with plexiglass protecting Access Services frontline staff and increased security. Librarians remain working and teaching primarily from their homes.

In late July, the Borland library in Jacksonville was asked to prepare for possible overnight housing of UF Health clinicians in the stillclosed library in the event of a hurricane. The library has stated its requirements (masks, social distancing etc.) UF Health would bring in mattresses for the clinicians, have someone stationed at the door to admit only those assigned to sleep there and have the space cleaned when done.



#### Re-Opening Plans

USF Health Libraries have been working with our central-service partners on campus, and the colleges, schools, and programs we support to prepare for re-opening during the Coronavirus pandemic.

The downtown USF Health library, the Florida Blue Health Knowledge Exchange, re-opened on July 20 when the Morsani College of Medicine semester started. Shimberg Health Sciences Library on the main university campus is scheduled to re-open to students on August 24.

The Access Services staff has continued working on-site in rotating shifts since the university closed in mid-March. They've been available to check-out laptops (appointments only), check-out circulating materials and mail items to patrons, and scan materials for Interlibrary Loan. The remainder of the staff has been working remotely, including all our student workers.

Steps to safeguard the health of staff and students at both locations include: installation of Plexiglass shields at our primary service points; installation of signage with mask-wearing, physical distancing, hand washing, and one-way-aisle messaging; requirement that everyone

wear a mask any time they are in campus buildings and not in a private office with the door closed; provision of two face masks and personal hand sanitizer bottles for staff; installation of campus vending machines where staff and students can swipe their ID for two free personal-size hand sanitizer bottles per month; restriction of student on-campus time to class time only (students are encouraged to not "hang out" before or after class); enhanced cleaning, including hourly rounds of the housekeeping staff to clean high-touch points; and acquisition of terminal-cleaning foggers to sanitize spaces; closure of classrooms, conference rooms, auditoriums, etc. if a contact trace report indicates a COVID-infected person was in those areas until those spaces can be fogged before being used again.



The COVID-19 pandemic has changed the way Augusta University operates, as it has other communities across the United States. The University Libraries invite students, staff, faculty, and Augusta University Health System personnel to reflect on these changes so that people in the future can have an understanding of how this pandemic has impacted us all. Just as we look back on first-hand accounts of the 1918 Spanish Flu, people of the future can look back on us and remember what we went through during this historic period.

Please submit an account of your experience of the pandemic over the last few months. Consider the following questions as writing prompts for your personal narrative.

#### General questions for everyone to ponder:

- · Did you lose your job-if so, were you able to take advantage of unemployment benefits or provisions of the CARE Act?
- · Did you telework—if so, what impact did this have on your lifestyle?
- · How did you handle taking care of your family (perhaps small children) and working from home at the same time?
- · How has quarantine impacted your lifestyle? Have you taken up new hobbies in reaction to having more free time?
- · How did you navigate other obstacles, such as restrictions on movement, wearing a mask in public, or the shutdown of places like hair salons and restaurants?

This past spring the University Libraries Heritage Unit created a digital project aimed at documenting and preserving Augusta University's experience of the COVID-19 pandemic. All members of the Augusta University community were invited to share personal narratives of how their lives have changed due the pandemic. The COVID-19 Project: Documenting Personal Narratives research guide provides information on how to submit personal narratives. Submitted narratives will be housed in Scholarly Commons, the institutional repository for Augusta University.

#### **Awards**

Melissa E. Johnson, Assistant Director, Reference and Education Services at the Reese Library and Sandra Bandy, Assistant Director for Content Management at the Greenblatt Library were awarded \$15,000 in funding from the Georgia Humanities CARES Act Emergency Operating Grant. The funds will be used to strengthen University Libraries e-book collection to help meet student learning and faculty information needs impacted by the COVID-19 disruption.

Jennifer Davis and Sandra Bandy were awarded the National Network of Libraries of Medicine (NNLM) Virtual <u>Library Carpentry Workshop</u> Hosting Award. They will host this online training for data management in early 2021. Librarians throughout Southern Chapter will be invited to attend this 16-hour online training. Look for more information in the coming months. This will be an opportunity for librarians to increase knowledge in the key evolving area for research and discovery. Major goals will include:

- Cut through the jargon terms and phrases of software development and data science and apply concepts from these fields in library tasks;
- Identify and use best practices in data structures;
- Learn how to programmatically transform and map data from one form to another;
- Work effectively with researchers, IT, and systems colleagues;
- Automate repetitive, error prone tasks.

## **MISSISSIPPI**

## Rowland Medical Library, University of Mississippi Medical Center, Jackson, MS

The Rowland Medical Library (RML) at the University of Mississippi Medical Center reopened on Monday, August 10, 2020, on a limited basis. Chameka Robinson, Assistant Director, Public Services, and Sarah Adcock, Reference Librarian, worked to arrange seating and desks on the first floor in accordance with social distancing guidelines to prepare for reopening. The second floor is currently restricted to library personnel and reservation-only use of carrels and group study rooms for student virtual interviews.



On August 17, 2020, the RML will be open 24/7. Library staff will be present from 7 am to 4:30 pm. The second floor will continue to be restricted. Additional security cameras have been strategically placed to assist with user safety.

Interlibrary Loan staff have worked diligently throughout the COVID closure serving the UMMC community and beyond. Staff were able to continue filling a significantly increased number of requests from on and off-site collections while many libraries did not have access to their physical collections.

The RML Archives Division is partnering with the UMMC Center for Bioethics and Medical Humanities, Millsaps College, and the Mississippi State Medical Association to conduct oral history interviews of medical professionals around the state. The records and transcripts are for the purpose of future presentations/publications and preservation of material.

## **SOUTH CAROLINA**

#### School of Medicine Library, University of South Carolina, Columbia, SC

The School of Medicine Library officially "reopened" on July 27 but has been accessible to select student groups since June 8. Access to the library is limited to School of Medicine students, faculty and staff via ID badge card swipe and is available to them 24/7. The Library has onsite staffing of its circulation desk during regular business hours. The majority of staff continue to mostly work remotely. Other services continue to be provided remotely. Seating capacity is significantly decreased due to physical distancing guidelines. Sneeze guards are in place at the circulation desk and on study tables in common areas and group study rooms. Face coverings are required at all times when in the library per university policy. To date, library users have been very compliant with all guidelines and policies.


